Dear Member of Edgmont Country Club:

This past season we received a great number of favorable comments about the improved conditions of the golf course and the improvements made by Mark Hendrixson, our superintendent, and his diligent crew. Mark will bring the same commitment to the winter projects to further improve the course for the 2015 season. The tree thinning program will continue which will improve air flow and sunlight on the fairways and greens.

We will start the 2015 season with new golf carts! They will be EZ GO TXT carts. A new design which is 48 volts verses the current 36 volt units.

Your renewal application for the 2015 golf season is enclosed. There are **no** changes in price for the dues or greens fees for next season. Your support is an integral part of our ability to offer you the best golf value year after year.

As was done last year, the 2015 dues collected will be deposited into a segregated debtor-in-possession account ("Restricted DIP Account"). The funds in the Restricted DIP Account will be drawn by the Club on a monthly basis as earned in accordance with the schedule on the reverse side of this letter. A refund will be issued to each member in accordance with the schedule, also on the reverse side, if the Club were to cease golf operations prior to or during the 2015 season.

The popular **early pay option** for golf membership is back and expanded. A **\$100** (previously \$50) credit will be applied to your account if the golf membership renewal application, addendum to the renewal application and payment are returned by December 31, 2015; and a **\$50 credit** if returned by January 20, 2015. For your convenience we have also made available a pdf version of the form which can be filled out online (visit <u>www.edgmont.com/cmembers.htm</u>), printed, signed, and then mailed with your payment.

New for 2015 - The buy one get one half price! All current members and former members who rejoin can sponsor a NEW member at half (1/2) price.

A preliminary calendar of events for the 2015 season is on the reverse side of this letter. The 2015 season is our 52^{nd} anniversary of the founding of the club and the 50^{th} anniversary of being open for 18 hole play.
